# Reminder: Code of Ethics Training Required for all REALTORS®

Effective January 1, 2013 through December 31, 2016, all REALTORS® throughout the country are required to complete Ethics Training of not less than 2.5 hours of instruction time as a condition of Membership in any REALTORS® Association. Pursuant to the National Association of REALTORS® (NAR) policy, failure to complete the required ethics training is considered a violation of Membership duty for which the REALTOR® must be suspended until required training is complete. This suspension includes not only local services, including MLS, but also access to all Wisconsin REALTORS® Association (WRA) and NAR Member-only services, such as the Legal Hotline.

A REALTOR® completing Ethics Training as a part of the New Member Orientation is not required to complete additional ethics training for this period. We will have record of you completing this requirement if you have attended the RASCW New Member Orientation since January 1, 2013, or have taken the 2015-2016 Continuing Education Course 4, Ethics and Fair Housing in Wisconsin, offered by the WRA.

Continuing Education providers other than the WRA may or may not meet the NAR requirements for course objectives and minimum criteria. You will need to confirm with your provider that approval has been received. If you have met the Ethics Training requirement by taking the CE course through a provider other than the WRA, please notify Beth at the RASCW office at <a href="mailto:beth@wisre.com">beth@wisre.com</a> so it can be noted in your Membership records.

If your CE provider does not meet approval, NAR has an online course available at no cost. <u>Click Here for NAR Online Code of Ethics Course.</u> The deadline is December 31, 2016.

In wanting to honor her outstanding qualities, RASCW is proud to present the 2016 Cindy Strange "Pay It Forward" Award to Kelli Ezzell.

Kelli is a current member of the Membership Networking Committee, and will be serving as 2017 Treasurer for the Women's Council of REALTORS®. Kelli has been an Affiliate Member of RASCW since 2004. In 2005 Kelli served on the Zoo Committee, which benefitted the Henry Vilas Zoo. In 2008, 2010 and 2012 Kelli served on the GUSTO (Getting United in Service to Others) Committee which supported our men and women serving our country overseas, as well as ringing a bell or two for the Salvation Army.

"Just Bakery" is an initiative of the Madison-area Urban Ministry where Kelli wants to pay it forward by donating the \$3,000 proceeds from this year's golf outing. "Just Bakery" is a vocational and employment training program specifically designed to meet the needs of men and women returning to the community after incarceration. The program provides classroom and hands on vocational training for men and women interested in food services careers. The three month program has four modules: 1) job readiness/life skills; 2) baking products and methods; 3) baking production; and 4) job internship/placement and mentoring. Participants who complete the program will be eligible to take an exam with the WI Baker's Association to obtain special training certification from the WBA.

# Updating your eKey

Your eKey updates via the Internet early each morning. This is the only time your eKey needs access to the Internet. Once updated, you can open keyboxes without access to the Internet.

If your eKey encounters a problem during its morning update, the Update Key icon will display with a red X through it. Please get used to checking the Update Key icon before going out on showings to make sure a red X does not display. If there is a red X, you can perform a manual update by pressing the Update Key icon. If this does not work, you can call KIMVoice for an update code. KIMVoice can be reached at 1-888-968-4032 or 1-877-788-4220. You will receive a 10-digit number to enter in your ekey app. As the KIMVoice numbers are not listed in your ekey app, we suggest you set up a Contact to store these numbers to your phone.

The general Supra Technical Support phone number comes up in the About section of your EKEY app (second screen). You can also get update codes here, but there are a few extra steps.

#### Are you still using a Supra ActiveKey?

If yes, please upgrade before December 9th. All ActiveKeys will be shut off on December 15th. Click here for a copy of the email sent to all ActiveKey users with instructions for upgrading.

# Entering Street Names in Paragon™

In order to ensure listing history is linked & properties are mapped correctly, please enter street names in accordance with MLS guidelines (available here). Some of the lesser known rules include:

- All alphabetic county roads should be entered as County Road (ex: County Road K)
- All numeric state highways & interstates should be entered as Hwy (ex: Hwy 51)
- If the street number begins with an alpha character (ex: N1234), please enter it in the street number field (not the directional field).
- · Vacant land that does not have a street number assigned should be entered with the lot number in the street number field. Please use the format: L24 (rather than Lot 24). If there is no lot number, list the acreage: 41.25 Ac.

#### Client Connect Interface Update

The Client Connect interface has been updated for the end-user client. The main reason for the update is to make Client Connect more mobile friendly. The functionality is basically the same, however the look and navigation have changed. You may want to check out the new interface so you are familiar with what your clients are now seeing. The easiest way to do this is to pull up your contact list and click on any blue Site button to be taken to that client's site. Your agent photo may require adjustment to fit into the new format. There is a crop tool within Client Connect Preferences that can help with this. The old home page message has been converted into a new "About Me" link, so you may want to review this verbiage.

It is the responsibility of RASCW to collect dues on behalf of the Wisconsin REALTORS® Association and the National Association of REALTORS®. Your Membership Renewal reflects the following:

- NAR dues are \$120 plus \$35 for the annual Public Awareness Campaign for a total of \$155.
- WRA dues are \$298 for REALTOR® Members and \$271 for State Affiliate Members. Renewals received after December 31, 2016 will be subject to the WRA reinstatement fees of \$75 for REALTORS® and \$25 for Affiliates.
- RASCW dues are \$170 for both REALTOR® and Affiliate Members. Renewals received after December 31, 2016 will be subject to a \$25 RASCW reinstatement fee.

There are three voluntary contributions included on your Membership Renewal.

- The first is a \$15 contribution to the RASCW Housing Foundation. The Foundation is your non-profit corporation dedicated to making homes affordable by providing low interest, deferred payment loans to gualified individuals to be used for the down payment and/or closing costs associated with the purchase of a home. Contributions to the Foundation are tax deductible as a charitable contribution. Please consider making a contribution to assist a new home owner in 2017. - The second is a \$35 contribution to RPAC. At the direction of the RASCW Board of Directors, these funds may be contributed on a nonpartisan basis to candidates for public office who support and protect the rights of home ownership and real estate interests important to your business.
- Lastly is a \$10 voluntary contribution to the Wisconsin REALTORS® Foundation. Contributions to the Foundation are tax deductible as a charitable contribution.



# 2016 FACTS

Celebrated our 100-Year Anniversary on January 28 with a big party! Thank you to all who joined us. A total of \$7,750 was raised for our Housing Foundation.

Through the efforts of the Affordable Housing Equal Opportunities Committee -

- Raised a record breaking \$8,300 at the 12th Annual Mallard's Game/Tailgate Fundraiser and donated the proceeds to Movin' Out, a non-profit organization that assists families dealing with disabilities.
- · Awarded 8 Minority Scholarships.

The Commercial Services Committee continued its efforts to better serve the interests and needs of the commercial broker highlighted by the monthly "Commercial Corner" in the *REALTOR\* Review* and partnering with the Professional Development Committee to offer programs with a commercial brokerage emphasis, highlighted by the annual Commercial Forecast presentation in January and the New Developments program in May.

The 22nd Annual Ghoulish Gallop and the Irv Stein Memorial Walk attracted 243 runners and walkers. Thanks to the participants and our generous sponsors, \$11,000 was raised for the REALTORS\* Association of South Central Wisconsin Housing Foundation. Many new additions included a Kick-Off Party, face painters, food carts and live music

The RASCW Housing Foundation has given out over \$2.4 million in loans since 1991, including 30 new loans (\$102,765) in 2016. This year's loans were provided to assist with down payments on homes purchased in Portage, Sun Prairie, Prairie du Chien, Beloit, Middleton, Mount Horeb, Dodgeville, Waunakee, Mazomanie, Lodi and Madison.

Through the efforts of the Government Affairs Committee we continued our partnership agreement with the WRA in the public policy area in order to take a more proactive role in the development of land use policies, issues affecting real estate and economic growth in our marketplaces.

The Membership Networking Committee kept it fun with the March Madness Tip Off, a Brewers Outing, the Cindy Strange Memorial Golf Outing, a Bocce Ball Tournament, Trivia Extravaganza and a Holiday Party. The Backpacks for Buddies campaign collected 154 backpacks plus 128 tubes of toothpaste, 124 toothbrushes, 50 toothbrush holders, 50 hand sanitizers, assorted toiletries, 6 soccer balls as well as cash donations. This brings our total to 1,787 suitcases, bags and backpacks plus many boxes of personal care items that have been donated for foster care programs throughout the counties in our region.

The Orientation Committee continued its efforts in providing a first class introduction to RASCW. Ten New Member Orientation sessions were held at the RASCW office and one in Platteville. Many dedicated Member volunteers gave their time to present these sessions.

The Professional Development Committee seeks out and plans educational opportunities for both REALTOR\* and Affiliate Members. Five programs were held throughout the year at no cost to Members.

Continued the formal Partnership agreement with the WRA in the areas of Continuing Education and forms sales for the 20th consecutive year.

Hosted two forums with Jennifer Cheatham, Superintendent of Madison Metropolitan School District, for members to receive an update on MMSD and to be among the first to receive material about the schools prepared especially for individuals and families considering a home purchase.

The Professional Standards Committee received 12 formal complaints: 7 ethics complaints and 5 arbitration requests plus 1 Ombudsman.

REALTORS\* Rider Team raised \$1,820 for Bike for Boys & Girls Club of Dane County.

Expanded our staff with the addition of Christina Santos, Professional Development and Program Director. Our membership has grown both in size and geography over the past several years. Among other duties, Christina will be working to bring programs and events to our outlying areas.



# 9 Home Safety Tips for the Holidays

The holidays are a wonderful time full of food, family get-togethers and traditions, but the holidays can also pose many safety concerns, so it's best to be cautious. From lighting candles to hanging Christmas lights, there are plenty of safety hazards that can occur during the holidays. Let's take a look at nine home safety tips for the holidays to keep you and your family safe.

#### Inspect Lights

Carefully look at your holiday light strings every year, and be sure to throw away any cracked lamp holders, frayed cords or loose connections. When you replace bulbs, you need to unplug the lights and match the voltage and wattage to the original bulb.

#### Buy a Fresh Tree

If you buy a live Christmas tree for your home, try to purchase a fresh tree since they are more fire resistant. Always keep your tree watered, and keep open flames away from it.

#### Lights Out

When you leave your house or go to sleep, make sure to turn off your holiday lights.

#### Timed Lights

Use a certified CSA International outdoor timer to switch on and off your holiday lights. Your lights should be turned on after 7:00 p.m. to avoid the electricity "rush hour."

#### Check for Certification

Your holiday lights, extension cords, spotlights, carbon monoxide alarms, gas appliances and electrical decorations should be certified by an accredited certification organization like CSA International, UL or ELT to make sure they comply with safety standards and performance. Look for the certification mark on the product package to ensure you are making a safe purchase.

# Don't Connect Extension Cords

You should never connect two or more extension cords together. Only use a single cord that is long enough to reach to the outlet you need without stretching.

# Keep Electrical Connectors Off the Ground

If you are hanging lights outside, keep electrical connectors off the ground and away from metal gutters. Also use insulated tape or plastic clips to keep lights secure.

# Choose the Right Ladder

Make sure you select the right ladder size for the job if you are putting up lights on your house. Check for a certification mark to make sure the ladder complies with safety standards.

# Check Your Furnace

Prevent CO hazards in your home by hiring a professional heating contractor to do a maintenance checkup of your furnace and ventilation system. You will want to clean or replace your furnace filter often during the winter months.
